Textual Information(1)	<p>The Company has allotted 4,20,000 equity shares pursuant to the conversion of 44,800 Convertible Warrants held by Mr. Gautam Udani and 3,75,200 Convertible Warrants held by Mr. Raja Debnath into equity shares on August 07, 2025. The in-principle approval for the issue and allotment of convertible warrants was received from BSE on March 04, 2024, and the listing approval for the said equity shares post conversion was received on October 03, 2025. However, the trading approval for these equity shares is pending with BSE as on the date of filing of this Shareholding Pattern. The Company has further issued 12,99,857 equity shares of face value Rs.10/- each to the Non-Promoters of the Company and 11,12,820 convertible warrants, each convertible into one equity share of face value Rs.10/-, to the Promoters and Non Promoters of the Company on a preferential basis, pursuant to the approval of the members at their meeting held on October 13, 2025. However the Company has not yet received the in principle approval from the stock exchange for the said allotment.</p>
